Dear Parent/Guardian:

Under Title VIII of the Elementary and Secondary Education Act, the Schertz-Cibolo-Universal City Independent School District (SCUCISD) is eligible to apply for Federal Impact Aid funds. SCUCISD is entitled to these funds based on the district's enrollment of students whose parents are federally connected such as Active Duty in the Uniformed Military Services, or Civilians employed on Federal Property.

In order for SCUCISD to apply for funds we have to be able to show record of our claim. The minimum information the Federal Government requires the district to obtain is printed on the reverse side of this letter. Please review and complete the form carefully. This form has been revised in an attempt to make the form easier to understand and to include additional information required by the United States Department of Education. It is essential that all persons that are federally connected complete this survey. Information needed is summarized below:

- A survey must be completed for every child that attends a school in SCUCISD.
- Verify all information is correct and accurate in Section 1.
- > If either parent/guardian is Active Duty in the Military Services as of October 30, 2020, completed Section 2 and skip to Section 4. If you are a dual military family complete the survey using one parent/guardian's information. If not mark No and continue survey at Section 3.
- > If either parent/guardian is a Civilian employed on Federal Property complete Section 3. If both parent/guardian work on Federal Property complete the survey using only one individuals information. If not mark No and continue survey at Section 4.
- > If you are not on Active Duty and are not a Civilian employed on Federal Property mark the survey no in both Sections 2 and 3 and skip to Sections 4 and 5.
- In Section 4 List all other children attending school in SCUCISD
- Section 5 Signature, Date, and Contact Phone Number
